Switzerland and China enjoy a special relationship: Switzerland was the first Western country to recognise the People's Republic of China in 1949 and the Swiss company Schindler founded the very first Western industrial joint venture in the People's Republic of China in 1980. More recently, Switzerland was among the first countries to recognise China's market economy status and then in 2014 entered into a Free Trade Agreement with China. Earlier this year China has established an "Innovation Strategic Partnership" with Switzerland. Such is the quality of bilateral relations between Switzerland at the heart of Europe and China that in fact, it also serves as a model for promoting Chinese-European cooperation.

At present around 600 Swiss firms with over 1'000 locations are already present in China employing over 200'000 people. In the coming years more technology-oriented Swiss companies than ever before will look at China as a location for sourcing, production or sales. Most of them are highly specialised market or technology leaders in their respective fields. Medium and small sized company's preference is to locate within Industrial or Technology Parks in China to become operational as quickly as possible thanks to the welcoming infrastructures and support services of the parks.

The "1st Chinese Industrial and Technology Park Fair" in Switzerland is a unique opportunity for Chinese Industrial and Technology Parks to present themselves to potential investors close to the clients' home base. The fair also serves to learn about the needs and expectations of advanced technology-oriented Swiss and European SMEs when setting down in China.
